**\*\*\*CAMPING RULES FOR CAMP SITES AT SANDUSKY SAILING CLUB (SSC)\*\*\***

1. The fee is \$20 per Camp Site, per night, and is limited to tents and pop-up campers.
2. All campers must be 21 years of age or older, unless accompanied by a parent or legal guardian for the duration of the regatta. Parents and legal guardians are responsible for campers under 21 years of age at all times. A parent or legal guardian must be present on SSC grounds at all times during the regatta, if a camper under 21 years of age for whom the adult is responsible is present.
3. Camping is permitted in designated areas only.
4. Quiet hours in camping areas are from 11:00 pm until 7 am. No noise that can be heard off SSC grounds is permitted. Otherwise, no noise that can be heard in adjacent camp sites is permitted during quiet hours.
5. Fires are NOT permitted on SSC grounds.
6. Campers are not permitted to utilize SSC water or electric utilities.
7. No person under the age of 21 may consume alcohol on SSC grounds. Any alcohol purchased from SSC must be consumed in the areas designated by SSC for alcohol consumption, including inside the clubhouse, and adjacent to the clubhouse on the front porch or in the pavilion. No adult may furnish alcohol to any person under the age of 21.
8. Generators are prohibited in the camp sites.
9. Campers are strictly liable for their dogs and must control them at all times. Dogs must be well-behaved, leashed, and campers must clean up after them.
10. All campers must follow any additional instructions given by representatives of SSC and any additional rules posted by SSC. If campers have any questions, please contact the Regatta Director or Club Manager.

**\*\*\*RELEASE AND INDEMNIFICATION\*\*\***

In consideration of being permitted to camp at the Sandusky Sailing Club, the Responsible Camper on behalf of himself/herself and all other campers on the Camp Site, including but not limited to any minor children or other Campers under the age of 21, hereby releases and forever discharges the Sandusky Sailing Club, its Officers, Trustees, agents, employees, successors, representatives, and assigns ("Released Parties") from any and all debts, claims, demands, liabilities, obligations, and causes of action that the Campers, their heirs, representatives, or assigns ("Releasers") may now or hereafter have against the Released Parties, arising out of or otherwise relating to camping at the Sandusky Sailing Club at any time, or from any other cause.

Releasers further agree that they shall indemnify and forever hold the Released Parties harmless from any and all claims, demands, causes of action, liabilities or expenses, including but not limited to attorneys' fees and litigation expenses, that may be asserted or may subsequently arise in connection with the claims and matters being released hereby.

THE RELEASORS STATE THAT THEY HAVE CAREFULLY READ THE FOREGOING RELEASE AND KNOW THE CONTENTS THEREOF, AND THEY ARE SIGNING THE SAME AS THEIR OWN FREE ACT.
